

**NOTICE OF INTENT TO ADOPT A NEGATIVE DECLARATION  
FOR THE INCORPORATION OF JURUPA VALLEY**

**NOTICE** is hereby given that the Riverside Local Agency Formation Committee (LAFCO) has completed and released a draft negative declaration with the accompanying initial study and supporting documents for the proposed Jurupa Valley Incorporation which, if approved, would submit to registered voters the question of whether or not the community of Jurupa Valley, California should become a general law city. Municipal decisions would pass from the County of Riverside to the newly formed city; no development is associated with the proposed project. The proposed City of Jurupa Valley boundaries are unincorporated territory east of Hamner Av., (at Limonite Av.)/Milliken Av., north to the San Bernardino county line, east to the City of Riverside, following the City of Riverside to the south and west to the I-15 freeway.

**NOTICE** is further given that the LAFCO Executive Officer will recommend that the Local Agency Formation Commission adopt a negative declaration for the project, which is to be considered by the Commission at its January 21, 2010 meeting at 9:30 a.m. in the Board of Supervisors Meeting Room, County Administrative Center, 4080 Lemon Street, 1<sup>st</sup> floor, Riverside, California. The purpose of this notice is to inform the public that the draft negative declaration with the accompanying initial study and supporting documents have been completed and are available for public review for a period of at least 30 days beginning the first date of publication, which is anticipated to be December 8, 2009 and ending on *January 7, 2010*. The draft negative declaration makes a finding that no significant effects will result from the project; the initial study and supporting documents identify the basis for the finding.
